### 4.1 Description of first aid measures

<b>Eye</b>	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

### 7.1 Precautions for safe handling

Large storage areas should have appropriate ventilation systems. Store as a Class C1 Combustible Liquid (AS1940).

### 16. OTHER INFORMATION
